> Bylaws of the
> Egyptian Board of REALTORS ${ }^{\ominus}$, Inc.

Article I-Name
Section 1. Name. The name of this organization shall be the Egyptian Board of REALTORS ${ }^{\ominus}$, Incorporated, hereinafter referred to as the "association".

Section 2. REALTORS. Inclusion and retention of the Registered Collective Membership Mark REALTORS ${ }^{\circledR}$ in the name of the Board shall be governed by the Constitution and Bylaws of the NATIONAL ASSOCIATION OF REALTORS ${ }^{\circledR}$ as from time to time amended.

Article II - Objectives
The objectives of the association are:
Section 1. To unite those engaged in the recognized branches of the real estate profession for the purpose of exerting a beneficial influence upon the profession and related interests.
Section 2. To promote and maintain high standards of conduct in the real estate profession as expressed in the Code of Ethics of the NATIONAL ASSOCIATION OF REALTORS ${ }^{\oplus}$.

Section 3. To provide a unified medium for real estate owners and those engaged in the real estate profession whereby their interests may be safeguarded and advanced.
Section 4. To further the interests of home and other real property ownership.
Section 5. To unite those engaged in the real estate profession in this community with the Illinois REALTORS ${ }^{\circledR}$ and the NATIONAL ASSOCIATION OF REALTORS ${ }^{\circledR}$, thereby furthering their own objectives throughout the state and nation and obtaining the benefits and privileges of membership therein.
Section 6. To designate, for the benefit of the public, individuals authorized to use the terms REALTOR ${ }^{\circledR}$ and REALTORS ${ }^{\circledR}$ as licensed, prescribed, and controlled by the NATIONAL ASSOCIATION OF REALTORS ${ }^{\circledR}$.

## Article III - Jurisdiction

Section 1. The territorial jurisdiction of the association as a Member of the NATIONAL ASSOCIATION OF REALTORS ${ }^{\circledR}$ is:

Alexander, Clay, Clinton (Townships of Irishtown, Carlyle, Lake, Clement, East Fork, Meridian, and Brookside ONLY), Edwards, Fayette, Franklin, Gallatin, Hamilton, Hardin, Jackson, Jasper, Jefferson, Johnson, Lawrence, Marion, Massac, Perry, Pope, Pulaski, Richland, Saline, Union, Wabash, Washington, Wayne, White, and Williamson.

Section 2. Territorial jurisdiction is defined to mean:
(a) The right and duty to control the use of the terms REALTOR ${ }^{\circledR}$ and REALTORS ${ }^{\circledR}$, subject to the conditions set forth in these Bylaws and those of the NATIONAL ASSOCIATION OF REALTORS ${ }^{\circledR}$, in return for which the association agrees to protect and safeguard the property rights of the National Association in the terms.

> Article IV - Membership

Section 1. There shall be six classes of members as follows:
(a) REALTOR ${ }^{\circledR}$ Members. REALTOR ${ }^{\circledR}$ Members, whether primary or secondary shall be:

(1) Individuals who, as sole proprietors, partners, corporate officers, or branch office managers, are engaged actively in the real estate profession, including buying, selling, exchanging, renting or leasing, managing, appraising for others for compensation, counseling, building, developing or subdividing real estate, and who maintain or are associated with an established real estate office in the state of Illinois or a state contiguous thereto. All persons who are partners in a partnership, or all officers in a corporation who are actively engaged in the real estate profession within the state or a state contiguous thereto shall qualify for REALTOR ${ }^{\circledR}$ membership only, and each is required to hold REALTOR ${ }^{\circledR}$ membership (except as provided in the following paragraph) in an association of REALTORS ${ }^{\circledR}$ within the state or a state contiguous thereto unless otherwise qualified for Institute Affiliate membership, as described in Section 1 (b) of Article IV.

In the case of a real estate firm, partnership, or corporation, whose business activity is substantially all commercial, only those principals actively engaged in the real estate business in connection with the same office, or any other offices within the jurisdiction of the association in which one of the firm's principals holds REALTOR ${ }^{\circledR}$ membership, shall be required to hold REALTOR ${ }^{\circledR}$ membership unless otherwise qualified for Institute Affiliate membership as described in Section 1 (b) of Article IV.

NOTE: REALTOR ${ }^{\circledR}$ members may obtain membership in a "secondary" association in another state.
(2) Individuals who are engaged in the real estate profession other than as sole proprietors, partners, corporate officers or branch office managers and are associated with a REALTOR ${ }^{\circledR}$ member and meet the qualifications set out in Article V.
(3) Franchise REALTOR ${ }^{\circledR}$ Membership. Corporate officers (who may be licensed or unlicensed) of a real estate brokerage franchise organization with at least one hundred fifty (150) franchisees located within the United States, its insular possessions and the commonwealth of Puerto Rico, elected to membership pursuant to the provisions in the NAR Constitution and Bylaws. Such individuals shall enjoy all of the rights, privileges and obligations of REALTOR ${ }^{\circledR}$ membership (including compliance with the Code of Ethics) except: obligations related to association-mandated education, meeting attendance, or indoctrination classes or other similar requirements; the right to use the term REALTOR ${ }^{\circledR}$ in connection with their franchise organization's name; and the right to hold elective office in the local association, state association and National Association. (Adopted 1/96)
(4) Primary and Secondary REALTOR ${ }^{\circledR}$ Members. An individual is a primary member if the association pays state and National dues based on such member. An individual is a secondary member if state and National dues are remitted through another association. One of the principals in a real estate firm must be a designated REALTOR ${ }^{\circledR}$ member of the association in order for licensees affiliated with the firm to select the association as their "primary" association.
(5) Designated REALTOR ${ }^{\circledR}$ Members. Each firm (or office in the case of firms with multiple office locations) shall designate in writing one REALTOR ${ }^{\circledR}$ member who shall be responsible for all duties and obligations of membership, including the obligation to arbitrate or to mediate pursuant to Article 17 of the Code of Ethics and the payment of association dues as established in Article X of the Bylaws. The "Designated REALTOR ${ }^{\text {®" }}$ must be a sole proprietor, partner, corporate officer or branch office manager acting on behalf of the firm's principal(s) and must meet all other qualifications for REALTOR ${ }^{\circledR}$ membership established in Article $V$, Section 2, of the Bylaws.

(b) Institute Affiliate Members. Institute Affiliate members shall be individuals who hold a professional designation awarded by an Institute, Society, or Council affiliated with the NATIONAL ASSOCIATION OF REALTORS ${ }^{\circledR}$ that addresses a specialty area other than residential brokerage or individuals who otherwise hold a class of membership in such Institute, Society or Council that confers the right to hold office. Any such individual, if otherwise eligible, may elect to hold REALTOR ${ }^{\circledR}$ membership, subject to payment of applicable dues for such membership. (Amended 1/02)
(c) Affiliate Members. Affiliate members shall be real estate owners and other individuals or firms who, while not engaged in the real estate profession as defined in paragraphs (a) or (b) of this section, have interests requiring information concerning real estate and are in sympathy with the objectives of the association. Licensed or certified appraisers who hold Affiliate membership are eligible for MLS participation as defined in Article XVIII - Multiple Listing, Section 3(a) of these Bylaws. (11/08)

> Affiliate membership shall also be granted to individuals licensed or certified to engage in real estate practice who, if otherwise eligible, do not elect to hold REALTOR ${ }^{\oplus}$ membership in the association, provided the applicant is engaged exclusively in a specialty of the real estate business other than brokerage of real property.
(d) Public Service Members. Public Service members shall be individuals who are interested in the real estate profession as employees of or affiliated with educational, public utility, governmental, or other similar organizations, but are not engaged in the real estate profession on their own account or in association with an established real estate business.
(e) Honorary Members. Honorary members shall be individuals not engaged in the real estate profession who have performed notable service for the real estate profession, for the association, or for the public.
(f) Student Members. Student members shall be individuals who are seeking an undergraduate or graduate degree with a specialization or major in real estate at institutions of higher learning, and who have completed at least two years of college and at least one college-level course in real estate but are not engaged in the real estate profession on their own account or not associated with an established real estate office.

> Article V - Qualification and Election

## Section 1. Application

(a) An application for membership shall be made in such manner and form as may be prescribed by the board of directors and made available to anyone requesting it. The application form shall contain among the statements to be signed by the applicant (1) that applicant agrees as a condition to membership to thoroughly familiarize himself/herself with the Code of Ethics of the NATIONAL ASSOCIATION OF REALTORS ${ }^{\circledR}$, the Constitutions, Bylaws, and Rules and Regulations of the association, the State and National Associations, and if elected a member, will abide by the Constitutions and Bylaws and Rules and Regulations of the association, State and National Associations, and if a REALTOR ${ }^{\circledR}$ member, will abide by the Code of Ethics of the NATIONAL ASSOCIATION OF REALTORS ${ }^{\circledR}$, including the obligation to arbitrate controversies arising out of real estate transactions as specified by Article I7 of the Code of Ethics, and as further specified in the Code of Ethics and Arbitration Manual of the NATIONAL ASSOCIATION OF REALTORS ${ }^{\circledR}$, as from time to time amended, and (2) that applicant

consents that the association, through its membership committee or otherwise, may invite and receive information and comment about applicant from any member or other persons, and that applicant agrees that any information and comment furnished to the association by any person in response to the invitation shall be conclusively deemed to be privileged and not form the basis of any action for slander, libel, or defamation of character. The applicant shall, with the form of application, have access to a copy of the Bylaws, Constitution, Rules and Regulations, and Code of Ethics referred to above. (Amended 11/11)

## Section 2. Qualification

(a) An applicant for REALTOR ${ }^{\circledR}$ membership who is a sole proprietor, partner, corporate officer, or branch office manager of a real estate firm shall supply evidence satisfactory to the association through its membership committee or otherwise, that he/she is actively engaged in the real estate profession, and maintains a current, valid real estate broker's or salesperson's license or is licensed or certified by an appropriate state regulatory agency to engage in the appraisal of real property, has a place of business within the state or a state contiguous thereto (unless a secondary member), has no record of recent or pending bankruptcy*, has no record of official sanctions involving unprofessional conduct**, agrees to complete a course of instruction covering the Bylaws and rules and regulations of the association, the Bylaws of the State Association, and the Constitution and Bylaws and Code of Ethics of the NATIONAL ASSOCIATION OF REALTORS ${ }^{\circledR}$, and shall pass such reasonable and nondiscriminatory written examination thereon as may be required by the committee, and shall agree that if elected to membership, he/she will abide by such Constitution, Bylaws, rules and regulations, and Code of Ethics. (Amended 1/05)

* No recent or pending bankruptcy is intended to mean that the applicant or any real estate firm in which the applicant is a sole proprietor, general partner, corporate officer or branch office manager, is not involved in any pending bankruptcy or insolvency proceedings or, has not been adjudged bankrupt in the past three (3) years. If a bankruptcy proceeding as described above exists, membership may not be rejected unless the association establishes that its interests and those of its members and the public could not be adequately protected by requiring that the bankrupt applicant pay cash in advance for association and MLS fees for up to one (1) year from the date that membership is approved or from the date that the applicant is discharged from bankruptcy (whichever is later). In the event that an existing member initiates bankruptcy proceedings, the member may be placed on a "cash basis" from the date that bankruptcy is initiated until one (1) year from the date that the member has been discharged from bankruptcy.
** No record of official sanctions involving unprofessional conduct is intended to mean that the association may only consider:
A. judgments against the applicant within the past three (3) years of violations of (1) civil rights laws, (2) real estate license laws, and (3) or other laws prohibiting unprofessional conduct against the applicant rendered by the courts or other lawful authorities
B. criminal convictions if (1) the crime was punishable by death or imprisonment in excess of one year under the law under which the applicant was convicted, and (2) no more than ten (10) years have elapsed since the date of the conviction or the release of the applicant from the confinement imposed for that conviction, whichever is the later date (Amended 5/07)
(b) Individuals who are actively engaged in the real estate profession other than as sole proprietors,

partners, corporate officers, or branch office managers, in order to qualify for REALTOR ${ }^{\circledR}$ membership, shall at the time of application, be associated either as an employee or as an independent contractor with a designated REALTOR ${ }^{\oplus}$ member of the association or a designated REALTOR ${ }^{\oplus}$ member of another association (if a secondary member) and must maintain a current, valid real estate broker's or salesperson's license or be licensed or certified by an appropriate state regulatory agency to engage in the appraisal of real property, has no record of official sanctions involving unprofessional conduct*, shall complete a course of instruction covering the Bylaws and rules and regulations of the association, the Bylaws of the State Association, and the Constitution and Bylaws and Code of Ethics of the NATIONAL ASSOCIATION OF REALTORS ${ }^{\circledR}$, and shall pass such reasonable and nondiscriminatory written examinations thereon as may be required by the membership committee and shall agree in writing that if elected to membership he/she will abide by such Constitution, Bylaws, rules and regulations, and the Code of Ethics. A. judgments against the applicant within the past three (3) years of violations of (1) civil rights laws, (2) real estate license laws, and (3) or other laws prohibiting unprofessional conduct against the applicant rendered by the courts or other lawful authorities
B. criminal convictions if (1) the crime was punishable by death or imprisonment in excess of one year under the law under which the applicant was convicted, and (2) no more than ten (10) years have elapsed since the date of the conviction or the release of the applicant from the confinement imposed for that conviction, whichever is the later date (Amended 5/07)
(c) The association will also consider the following in determining an applicant's qualifications for REALTOR ${ }^{\circledR}$ membership:

1. All final findings of Code of Ethics violations and violations of other membership duties in this or any other REALTOR ${ }^{\circledR}$ association within the past three (3) years
2. Pending ethics complaints (or hearings)
3. Unsatisfied discipline pending
4. Pending arbitration requests (or hearings)
5. Unpaid arbitration awards or unpaid financial obligations to this or any other REALTOR ${ }^{\circledR}$

Association or REALTOR ${ }^{\circledR}$ association MLS
6. Any misuse of the term REALTOR ${ }^{\circledR}$ or REALTORS ${ }^{\circledR}$ in the name of the applicant's firm.
"Provisional" membership may be granted in instances where ethics complaints or arbitration requests (or hearings) are pending in other associations or where the applicant for membership has unsatisfied discipline pending in another association (except for violations of the Code of Ethics; See Article V, Section 2(a) NOTE 2) provided all other qualifications for membership have been satisfied. Associations may reconsider the membership status of such individuals when all pending ethics and arbitration matters (and related discipline) have been resolved or if such matters are not resolved within six months from the date that provisional membership is approved. Provisional members shall be considered REALTORS ${ }^{\circledR}$ and shall be subject to all of the same privileges and obligations of REALTOR ${ }^{\circledR}$ membership. If a member resigns from another association with an ethics complaint or arbitration request pending, the association may condition membership on the applicant's certification that he/she will submit to the pending ethics or arbitration proceeding (in accordance with the established procedures of the association to which the applicant has made application) and will abide by the decision of the hearing panel. Section 3. Election. The procedure for election to membership shall be as follows:
(a) The chief staff executive (or duly authorized designee) shall determine whether the applicant is applying for the appropriate class of membership. If the association has adopted provisional membership, applicants for REALTOR ${ }^{\circledR}$ membership may be granted provisional membership immediately upon submission of a completed application form and remittance of applicable association dues and any application fee Provisional members shall be considered REALTORS ${ }^{\circledR}$ and shall be subject to all of the same privileges and obligations of membership. Provisional membership is granted subject to subsequent review of the application by the board of directors.
(b) If the board of directors determines that the individual does not meet all of the qualifications for membership as established in the association's Bylaws, or, if the individual does not satisfy all of the requirements of membership (for example, completion of a mandatory orientation program) within 90 days from the association's receipt of their application, membership may, at the discretion of the board of directors, be terminated. In such instances, dues shall be returned to the individual less a prorated amount to cover the number of days that the individual received association services and any application fee. The board of directors shall vote on the applicant's eligibility for membership. If the applicant receives a majority vote of the board of directors, he/she shall be declared elected to membership and shall be advised by written notice.
(c) The board of directors may not without providing the applicant with advance notice of the findings, an opportunity to appear before the board of directors, to call witnesses on his/her behalf, to be represented by counsel, and to make such statements as he/she deems relevant. The board of directors may also have counsel present. The board of directors shall require that written minutes be made of any hearing before it or may electronically or mechanically record the proceedings.
(d) If the board of directors determines that, the application should be rejected, it shall record its reasons with the chief executive (or duly authorized designee). If the board of directors believes that denial of membership may become the basis of litigation and a claim of damage by a provisional member, it may specify that denial shall become effective upon entry in a suit by the association for a declaratory judgment by a court of competent jurisdiction of a final judgment declaring that the termination violates no rights of the individual. (Adopted 1/98, Amended 1/05)
Section 4. New Member Code of Ethics Orientation. Applicants for REALTOR ${ }^{\circledR}$ membership and provisional REALTOR ${ }^{\circledR}$ members (where applicable) shall complete an orientation program on the Code of Ethics of not less than two (2) hours and thirty (30) minutes of instructional time. This requirement does not apply to applicants for REALTOR ${ }^{\circledR}$ membership or provisional members who have completed comparable orientation in another association, provided that REALTOR ${ }^{\circledR}$ membership has been continuous, or that any break in membership is for one (1) year or less.
Failure to satisfy this requirement within 90 days of the date that provisional membership was granted, will result in denial of the membership application or termination of provisional membership. The Association Executive may grant an extension to this provision for extreme hardship cases.

Section 5. Continuing Member Code of Ethics Training. Effective January 1, 2019, through December 31, 2021, and for successive three year periods thereafter, each REALTOR ${ }^{\circledR}$ member of the association (with the exception of REALTOR ${ }^{\circledR}$ members granted REALTOR ${ }^{\circledR}$ Emeritus status by the National Association) shall be required to complete ethics training of not less than two (2) hours and thirty (30) minutes of instructional time. This requirement will be satisfied upon presentation of documentation

that the member has completed a course of instruction conducted by this or another Realtor ${ }^{\circledR}$ association, the State Association of REALTORS ${ }^{\circledR}$, the NATIONAL ASSOCIATION OF REALTORS® ${ }^{\circledR}$, which meets the learning objectives and minimum criteria established by the NATIONAL ASSOCIATION of REALTORS ${ }^{\circledR}$ from time to time. REALTOR ${ }^{\circledR}$ members who have completed training as a requirement of membership in another association and REALTOR ${ }^{\circledR}$ members who have completed the New Member Code of Ethics Orientation during any three (3) year cycle shall not be required to complete additional ethics training until a new three (3) year cycle commences. (Amended 09/2020)

Failure to satisfy the required periodic ethics training shall be considered a violation of a membership duty. Failure to meet the requirement in any three (3) year cycle will result in suspension of membership for the first two months (January and February) of the year following the end of any three (3) year cycle or until the requirement is met, whichever occurs sooner. On March 1 of that year, the membership of a member who is still suspended as of that date will be automatically terminated (Adopted 1/01, Amended 11/08, Amended 11/2016) (Amended 09/2020)
Section 6. Status Changes.
(a) A REALTOR ${ }^{\circledR}$ who changes the conditions under which he/she holds membership shall be required to provide written notification to the association within thirty (30) days. A REALTOR ${ }^{\circledR}$ (non-principal) who becomes a principal in the firm with which he/she has been licensed or, alternatively, becomes a principal in a new firm which will be comprised of REALTOR ${ }^{\circledR}$ principals may be required to satisfy any previously unsatisfied membership requirements applicable to REALTOR ${ }^{\circledR}$ (principal) members but shall, during the period of transition from one status of membership to another, be subject to all of the privileges and obligations of a REALTOR ${ }^{\circledR}$ (principal). If the REALTOR ${ }^{\circledR}$ (non-principal) does not satisfy the requirements established in these Bylaws for the category of membership to which they have transferred within 30 days of the date they advised the association of their change in status, their new membership application will terminate automatically unless otherwise so directed by the board of directors.
A REALTOR ${ }^{\circledR}$ who is transferring his/her license from one firm comprised of REALTOR ${ }^{\circledR}$ principals to another firm comprised of REALTOR ${ }^{\circledR}$ principals shall be subject to all of the privileges and obligations of membership during the period of transition. If the transfer is not completed within 30 days of the date the association is advised of the disaffiliation with the current firm, membership will terminate automatically unless otherwise so directed by the board of directors.
(The board of directors, at its discretion, may waive any qualification that the applicant has already fulfilled in accordance with the association's Bylaws.)
(b) Any application fee related to a change in membership status shall be reduced by an amount equal to any application fee previously paid by the applicant.
(c) Dues shall be prorated from the first day of the month in which the member is notified of election by the board of directors and shall be based on the new membership status for the remainder of the year.

## Article VI - Privileges and Obligations

Section 1. The privileges and obligations of members, in addition to those otherwise provided in these Bylaws, shall be specified in this Article.
Section 2. Any member of the association may be reprimanded, fined, placed on probation, suspended

or expelled by the board of directors for a violation of these and association rules and regulations consistent with these Bylaws, after a hearing as provided in the Code of Ethics and Arbitration Manual of the association. Although members other than REALTORS ${ }^{\circledR}$ are not subject to the Code of Ethics, or its enforcement by the association, such members are encouraged to abide by the principles established in the Code of Ethics of the NATIONAL ASSOCIATION OF REALTORS ${ }^{\circledR}$ and conduct their business and professional practices accordingly. Further, members other than REALTORS ${ }^{\circledR}$ may, upon recommendation of the membership committee, or upon recommendation by a hearing panel of the professional standards committee, be subject to discipline as described above, for any conduct, which in the opinion of the board of directors, applied on a nondiscriminatory basis, reflects adversely on the terms REALTOR ${ }^{\circledR}$ or REALTORS ${ }^{\circledR}$, and the real estate industry, or for conduct that is inconsistent with or adverse to the objectives and purposes of the local association, the State Association, and the NATIONAL ASSOCIATION OF REALTORS ${ }^{\circledR}$.

Section 3. Any REALTOR ${ }^{\circledR}$ member of the association may be disciplined by the board of directors for violations of the Code of Ethics or other duties of membership, after a hearing as described in the Code of Ethics and Arbitration Manual of the association, provided that the discipline imposed is consistent with the discipline authorized by the Professional Standards Committee of the NATIONAL ASSOCIATION OF REALTORS ${ }^{\circledR}$ as set forth in the Code of Ethics and Arbitration Manual of the National Association.

Section 4. Resignations of members shall become effective when received in writing by the board of directors, provided, however, that if any member submitting the resignation is indebted to the association for dues, fees, fines, or other assessments of the association or any of its services, departments, divisions, or subsidiaries, the association may condition the right of the resigning member to reapply for membership upon payment in full of all such monies owed.

Section 5. If a member resigns from the association or otherwise causes membership to terminate with an ethics complaint pending, the complaint shall be processed until the decision of the association with respect to disposition of the complaint is final by this association (if respondent does not hold membership in any other association) or by any other association in which the respondent continues to hold membership. If an ethics respondent resigns or otherwise causes membership in all Boards to ruminate before an ethics complaint is filed alleging unethical conduct occurred while the respondent was a REALTOR ${ }^{\oplus}$, the complaint, once filed, shall be processed until the decision of the association with respect to disposition of the complaint is final. In any instance where an ethics hearing is held subsequent to an ethic respondent's resignation or membership termination, any discipline ratified by the Board of Directors shall be held in abeyance until such time as the respondent rejoins an association of REALTORS ${ }^{\circledR}$.
(a) If a member resigns or otherwise causes membership to terminate, the duty to submit to arbitration continues in effect even after membership lapses or is terminated, provided that the dispute arose while the former member was a REALTOR ${ }^{\circledR}$. (Amended $1 / 00$ and 11/11)

Section 6. REALTOR ${ }^{\circledR}$ Members. REALTOR ${ }^{\circledR}$ members, whether primary or secondary, in good standing are entitled to vote and to hold elective office in the association; and may use the terms REALTOR ${ }^{\circledR}$.
For purposes of this section, the term "good standing" means the member satisfies the "Obligations of REALTOR ${ }^{\circledR}$ Members, is current with all financial and disciplinary obligations to the association and

MLS, has completed any new member requirements, and complies with NAR's trademark rules.
(a) If a REALTOR ${ }^{\circledR}$ member is a sole proprietor in a firm, a partner in a partnership or an officer in a corporation, and is suspended or expelled, the firm, partnership or corporation shall not use the terms REALTOR ${ }^{\circledR}$ or REALTORS ${ }^{\circledR}$ in connection with its business during the period of suspension, or until readmission to REALTOR ${ }^{\circledR}$ membership, or unless connection with the firm, partnership or corporation is severed, or management control is relinquished, whichever may apply. The membership of all other principals, partners, or corporate officers shall suspend or terminate during the period of suspension of the disciplined member, or until readmission of the disciplined member or unless connection of the disciplined member with the firm, partnership, or corporation is severed, or unless the REALTOR ${ }^{\circledR}$ who is suspended or expelled removes himself/herself from any form or degree of management control of the firm for the term of the suspension or until readmission to membership, whichever may apply. Removal of an individual from any form or degree of management control, must be certified to the association by the member who is being suspended or expelled and by the individual who is assuming management control and the signatures of such certification must be notarized. In the event the suspended or expelled member is so certified to have relinquished all form or degree of management control of the firm, the membership of other partners, corporate officers, or other individuals affiliated with the firm shall not be affected, and the firm, partnership or corporation may continue to use the terms REALTOR ${ }^{\circledR}$ and REALTORS ${ }^{\circledR}$ in connection with its business during the period of suspension or until the former member is admitted to membership in the association. The foregoing is not intended to preclude a suspended or expelled member from functioning as an employee or independent contractor, providing no management control is exercised. Further, the membership of REALTORS ${ }^{\circledR}$ other than principals who are employed or affiliated as independent contractors with the disciplined member shall suspend or terminate during the period of suspension of the disciplined member or until readmission of the disciplined member, or unless connection of the disciplined member with the firm, partnership, or corporation is severed, or management control is relinquished, or unless the REALTOR ${ }^{\circledR}$ member (non-principal) elects to sever his/her connection with the REALTOR ${ }^{\circledR}$ and affiliate with another REALTOR ${ }^{\circledR}$ member in good standing in the association, whichever may apply.

If a REALTOR ${ }^{\circledR}$ member other than a sole proprietor in a firm, partner in a partnership, or an officer of a corporation is suspended or expelled, the use of the terms REALTOR ${ }^{\circledR}$ or REALTORS ${ }^{\circledR}$ by the firm, partnership or corporation shall not be affected.
(b) In any action taken against a REALTOR ${ }^{\circledR}$ member for suspension or expulsion under Section 6(a) hereof, notice of such action shall be given to all REALTORS ${ }^{\circledR}$ employed by or affiliated as independent contractors with such REALTOR ${ }^{\circledR}$ member and they shall be advised that the provisions in Article VI, Section 6(a) shall apply.

Section 7. Institute Affiliate Members. Institute Affiliate members shall have rights and privileges and be subject to obligations prescribed by the board of directors consistent with the Constitution and Bylaws of the NATIONAL ASSOCIATION OF REALTORS ${ }^{\circledR}$.
Section 8. Affiliate Members. Affiliate members shall have rights and privileges and be subject to obligations prescribed by the board of directors.

Section 9. Public Service Members. Public Service members shall have rights and privileges and be subject to obligations prescribed by the board of directors.

Section 10. Honorary Members. Honorary membership shall confer only the right to attend meetings

and participate in discussions.
Section 11. Student Members. Student members shall have rights and privileges and be subject to obligations prescribed by the board of directors.
Section 12. Certification by REALTOR ${ }^{\circledR}$. "Designated" REALTOR ${ }^{\circledR}$ members of the association shall certify to the association during the month of August on a form provided by the association, a complete listing of all individuals licensed or certified in the REALTOR's office(s) and shall designate a primary association for each individual who holds membership. Designated REALTORS® ${ }^{\text {s }}$ shall also identify any non-member licensees in the REALTOR's office(s) and if Designated REALTOR ${ }^{\circledR}$ dues have been paid to another association based on said non-member licensees, the Designated REALTOR ${ }^{\circledR}$ shall identify the association to which dues have been remitted. These declarations shall be used for purposes of calculating dues under Article X, Section 2(a) of the Bylaws. "Designated" REALTOR ${ }^{\circledR}$ members shall also notify the association of any additional individual(s) licensed or certified with the firm(s) within 30 days of the date of affiliation or severance of the individual.

Section 13. Legal Liability Training. Within two (2) years of the date of election to membership, and every two (2) years thereafter, each REALTOR ${ }^{\circledR}$ member of the association shall be required to demonstrate that they have completed a course of instruction on antitrust laws, agency laws, civil rights laws or the REALTORS ${ }^{\circledR}$ Code of Ethics, its interpretation and meaning and/or the procedures related to its enforcement.
This requirement will be considered satisfied upon presentation of evidence that the member has completed an educational program conducted by another Member Board, the State Association of REALTORS ${ }^{\circledR}$, the NATIONAL ASSOCIATION OF REALTORS ${ }^{\circledR}$ or any of its affiliated Institutes, Societies or Councils, or any other recognized educational institution which, in the opinion of the board of directors, is an adequate substitute for the training programs conducted by the association. Failure to satisfy this requirement biennially will result in membership being suspended from the date it otherwise would be renewed until such time that the member provides evidence of completion of the aforementioned educational requirements.

Section 14. Harassment. Any member of the association may be reprimanded, placed on probation, suspended or expelled for harassment of an association or MLS employee or association officer or director after an investigation in accordance with the procedures of the association. As used in this section, harassment means any verbal or physical conduct including threatening or obscene language, unwelcome sexual advances, stalking, actions including strikes, shoves, kicks, or other similar physical contact, or threats to do the same, or any other conduct with the purpose or effect of unreasonably interfering with an individual's work performance by creating a hostile, intimidating or offensive work environment. The decision of the appropriate disciplinary action to be taken shall be made by the investigatory team comprised of the president, and president-elect and/or vice president and one member of the board of directors selected by the highest-ranking officer not named in the complaint, upon consultation with legal counsel for the association. Disciplinary action may include any sanction authorized in the association's Code of Ethics and Arbitration Manual. If the complaint names the president, president-elect or vice president, they may not participate in the proceedings and shall be replaced by the immediate past president or, alternatively, by another member of the board of directors selected by the highest-ranking officer not named in the complaint.

## Article VII - Professional Standards and Arbitration

Section 1. The responsibility of the association and of association members relating to the enforcement of the Code of Ethics, the disciplining of members, and the arbitration of disputes, and the organization and procedures incident thereto shall be governed by the Code of Ethics and Arbitration Manual of NATIONAL ASSOCIATION OF REALTORS ${ }^{\circledR}$ as amended from time to time, which by this reference incorporated into these Bylaws, provided, however, that any provision deemed inconsistent with state law shall be deleted or amended to comply state law.
Section 2. It shall be the duty and responsibility of every REALTOR ${ }^{\circledR}$ member of this association to safeguard and promote the standards, interests, and welfare of the association and the real estate profession, and to protect against conduct that may cause a lack of public confidence in the real estate profession or in REALTORS ${ }^{\circledR}$. REALTOR ${ }^{\circledR}$ members also must abide by the governing documents and the policies of the association, the State Association, and the NATIONAL ASSOCIATION OF REALTORS ${ }^{\circledR}$, as well as the Code of Ethics of the NATIONAL ASSOCIATION OF REALTORS ${ }^{\circledR}$ including the duty to mediate and arbitrate controversies arising out of real estate transactions as specified by Article 17 of the Code of Ethics, and in accordance with the procedures set forth in the Code of Ethics and Arbitration Manual (Amended 11/11, 11/21)
Every REALTOR ${ }^{\circledR}$ member shall maintain a high level of integrity and adhere to the association's membership criteria. Any violent act or threat of violence to person or property, hateful conduct, or acts of moral turpitude impacting the public shall not be tolerated and may be cause for disciplinary action, up to and including termination of membership. (11/21)

Section 3. The responsibility of the association and association members relating to the enforcement of the Code of Ethics, the disciplining of members, the arbitration of disputes, and the organization and procedures incident thereto, shall be consistent with the cooperative professional standards enforcement agreement entered into by the association, which by this reference is made a part of these Bylaws.
Section 4. Professional Standards hearings and disciplines will be conducted by the Illinois REALTORS ${ }^{\circledR}$ upon review and submission by the association's Grievance Committee. (Adopted by EBOR 03/15)

\text { Article VIII - Use of the Terms REALTOR }{ }^{\circledR} \text { and REALTORS }{ }^{\circledR}
$$

Section 1. Use of the terms REALTOR ${ }^{\circledR}$ and REALTORS ${ }^{\circledR}$ by members shall, at all times, be subject to the provisions of the Constitution and Bylaws of the NATIONAL ASSOCIATION OF REALTORS ${ }^{\circledR}$ and to the Rules and Regulations prescribed by its board of directors. The association shall have the authority to control, jointly and in full cooperation with the NATIONAL ASSOCIATION OF REALTORS ${ }^{\circledR}$, use of the terms within its jurisdiction. Any misuse of the terms by members is a violation of a membership duty and may subject members to disciplinary action by the board of directors after a hearing as provided for in the association's Code of Ethics and Arbitration Manual. (Amended 5/06)
Section 2. REALTOR ${ }^{\circledR}$ members of the association shall have the privilege of using the terms REALTOR ${ }^{\circledR}$ and REALTORS ${ }^{\circledR}$ in connection with their places of business within the state or a state contiguous thereto so long as they remain REALTOR ${ }^{\circledR}$ members in good standing. No other class of members shall have this privilege. (Amended 1/96)
Section 3. A REALTOR ${ }^{\circledR}$ member who is a principal of a real estate firm, partnership, or corporation may use the terms REALTOR ${ }^{\circledR}$ and REALTORS ${ }^{\circledR}$ only if all the principals of such firm, partnership, or

corporation who are actively engaged in the real estate profession within the state or a state contiguous thereto are REALTOR ${ }^{\oplus}$ members or Institute Affiliate members as described in Section 1(b) of Article IV.
(a) In the case of a REALTOR ${ }^{\circledR}$ member who is a principal of a real estate firm, partnership, or corporation whose business activity is substantially all commercial, the right to use the term REALTOR ${ }^{\circledR}$ or REALTORS ${ }^{\circledR}$ shall be limited to office locations in which a principal, partner, corporate officer, or branch office manager of the firm, partnership, or corporation holds REALTOR ${ }^{\circledR}$ membership. If a firm, partnership, or corporation operates additional places of business in which no principal, partner, corporate officer, or branch office manager holds REALTOR ${ }^{\circledR}$ membership, the term REALTOR ${ }^{\circledR}$ or REALTORS ${ }^{\circledR}$ may not be used in any reference to those additional places of business. (Amended 1/01)

Section 4. Institute Affiliate members shall not use the terms REALTOR ${ }^{\circledR}$ or REALTORS ${ }^{\circledR}$, nor the imprint of the emblem seal of the NATIONAL ASSOCIATION OF REALTORS ${ }^{\circledR}$.

Article IX - State and National Memberships
Section 1. The association shall be a member of the NATIONAL ASSOCIATION OF REALTORS® and the Illinois REALTORS ${ }^{\circledR}$. By reason of the association's membership, each REALTOR ${ }^{\circledR}$ member of the Member Board shall be entitled to membership in the NATIONAL ASSOCIATION OF REALTORS ${ }^{\circledR}$ and the Illinois REALTORS ${ }^{\circledR}$ without further payment of dues. The association shall continue as a member of the State and National Associations, unless by a majority vote of all of its REALTOR ${ }^{\circledR}$ members, decision is made to withdraw, in which case the State and National Associations shall be notified at least one month in advance of the date designated for the termination of such membership.
Section 2. The association recognizes the exclusive property rights of the NATIONAL ASSOCIATION OF REALTORS ${ }^{\circledR}$ in the terms REALTOR ${ }^{\circledR}$ and REALTORS ${ }^{\circledR}$. The association shall discontinue use of the terms in any form in its name, upon ceasing to be a member of the National Association, or upon a determination by the board of directors of the National Association that it has violated the conditions imposed upon the terms.

Section 3. The association adopts the Code of Ethics of the NATIONAL ASSOCIATION OF REALTORS ${ }^{\circledR}$ and agrees to enforce the Code among its REALTOR ${ }^{\circledR}$ members. The association and all of its members agree to abide by the Constitution, Bylaws, Rules and Regulations, and policies of the National Association and the Illinois REALTORS ${ }^{\circledR}$.

Article X-Dues and Assessments
Section 1. Application Fee. The board of directors may adopt an application fee for REALTOR ${ }^{\circledR}$ membership in reasonable amount, not exceeding three (3) times the amount of the annual dues for REALTOR ${ }^{\circledR}$ membership, which shall be required to accompany each application for REALTOR ${ }^{\circledR}$ membership and which shall become the property of the association upon final approval of the application. (Amended 1/02)
Section 2. Dues. The annual dues of members shall be as follows:
(a) REALTOR ${ }^{\circledR}$ Members. The annual dues of each designated REALTOR ${ }^{\circledR}$ member shall be in such amount as established annually by the board of directors, plus an additional amount to be established annually by the board of directors times the number of real estate salespersons and licensed or certified appraisers who (1) are employed by or affiliated as independent contractors, or who are

otherwise directly or indirectly licensed with such REALTOR ${ }^{\circledR}$ member, and (2) are not REALTOR ${ }^{\circledR}$ members of any association in the state or a state contiguous thereto or Institute Affiliate members of the association. In calculating the dues payable to the association by a designated REALTOR ${ }^{\circledR}$ member, non-member licensees as defined in (1) and (2) of this paragraph shall not be included in the computation of dues if the designated REALTOR ${ }^{\circledR}$ has paid dues based on said non-member licensees in another association in the state or a state contiguous thereto, provided the designated REALTOR ${ }^{\circledR}$ notifies the association in writing of the identity of the association to which dues have been remitted. In the case of a designated REALTOR ${ }^{\circledR}$ member in a firm, partnership, or corporation whose business activity is substantially all commercial, any assessments for non-member licensees shall be limited to licensees affiliated with the designated REALTOR ${ }^{\circledR}$ (as defined in (1) and (2) of this paragraph) in the office where the designated REALTOR ${ }^{\circledR}$ holds membership, and any other offices of the firm located within the jurisdiction of this association. (Amended 1/05)

For the purpose of this section, a REALTOR ${ }^{\circledR}$ member of a Member Board shall be held to be any member who has a place or places of business within the state or a state contiguous thereto and who, as a principal, partner, corporate officer, or branch office manager of a real estate firm, partnership, or corporation, is actively engaged in the real estate profession as defined in Article III, Section I, of the Constitution of the NATIONAL ASSOCIATION OF REALTORS ${ }^{\circledR}$. An individual shall be deemed to be licensed with a REALTOR ${ }^{\circledR}$ if the license of the individual is held by the REALTOR ${ }^{\circledR}$, or by any broker who is licensed with the REALTOR ${ }^{\oplus}$, or by any entity in which the REALTOR ${ }^{\circledR}$ has a direct or indirect ownership interest and which is engaged in other aspects of the real estate business (except as provided for in Section 2 (a) (1) hereof) provided that such licensee is not otherwise included in the computation of dues payable by the principal, partner, corporate officer, or branch office manager of the entity.
A REALTOR ${ }^{\circledR}$ with a direct or indirect ownership interest in an entity engaged exclusively in soliciting and/or referring clients and customers to the REALTOR ${ }^{\circledR}$ for consideration on a substantially exclusive basis shall annually file with the association on a form approved by the association a list of the licensees affiliated with that entity and shall certify that all of the licensees affiliated with the entity are solely engaged in referring clients and customers and are not engaged in listing, selling, leasing, renting, managing, counseling or appraising real property. The individuals disclosed on such form shall not be deemed to be licensed with the REALTOR ${ }^{\circledR}$ filing the form for purposes of this Section and shall not be included in calculating the annual dues of the designated REALTOR ${ }^{\circledR}$. Designated REALTORS ${ }^{\circledR}$ shall notify the association within three (3) days of any change in status of licensees in a referral firm.
The exemption for any licensee included on the certification form shall automatically be revoked upon the individual being engaged in real estate licensed activities (listing, selling, leasing, renting, managing, counseling or appraising real property) other than referrals, and dues for the current fiscal year shall be payable.
Membership dues shall be prorated for any licensee included on a certification form submitted to the association who during the same calendar year applies for REALTOR ${ }^{\circledR}$ membership in the association. However, membership dues shall not be prorated if the licensee held REALTOR ${ }^{\circledR}$ membership during the preceding calendar year. (Amended 11/09 and 11/14)
(b) REALTOR ${ }^{\circledR}$ Members. The annual dues of REALTOR ${ }^{\circledR}$ members other than the designated REALTOR ${ }^{\circledR}$ shall be as established annually by the board of directors. (Amended 1/05)

(c) Institute Affiliate Members. The annual dues of each Institute Affiliate member shall be as established in Article II of the Bylaws of the NATIONAL ASSOCIATION OF REALTORS®.
(d) Affiliate Members. The annual dues of each Affiliate member shall be as established annually by the board of directors. (Amended 1/05)
(e) Public Service Members. The annual dues of each Public Service member shall be as established annually by the board of directors. (Amended 1/05)
(f) Honorary Members. Dues payable, if any, shall be at the discretion of the board of directors. (Amended 1/05)
(g) Student Members. Dues payable, if any, shall be at the discretion of the board of directors. (Amended 1/05)
Section 3. Dues Payable. Dues for all members shall be payable annually in advance on the first day of October. Dues for new members shall be computed from the date of application and granting of provisional membership. (Adopted 1/98, Amended 1/05)
(a) In the event a sales licensee or licensed or certified appraiser who holds REALTOR ${ }^{\circledR}$ membership is dropped for nonpayment of association dues, and the individual remains with the designated REALTOR’s firm, the dues obligation of the "designated" REALTOR ${ }^{\circledR}$ (as set forth in Article X, Section 2(a)) will be increased to reflect the addition of a non-member licensee. Dues shall be calculated from the first day of the current fiscal year and are payable within thirty (30) days of the notice of termination.

Section 4. Nonpayment of Financial Obligations. If dues, fees, fines or other assessments including amounts owed to the association or the association's multiple listing service are not paid within one (I) month after the due date, the nonpaying Member is subject to suspension at the discretion of the board of directors. Two (2) months after the due date, membership of the nonpaying member may be terminated at the discretion of the board of directors. Three (3) months after the due date, membership of the nonpaying Member shall automatically terminate unless within that time the amount due is paid. However, no action shall be taken to suspend or expel a member for nonpayment of disputed amounts until the accuracy of the amount owed has been confirmed by the board of directors. A former member who has had his/her membership terminated for nonpayment of dues, fees, fines, or other assessments duly levied in accordance with the provisions of these Bylaws or the provisions of other rules and regulations of the association or any of its services, departments, divisions or subsidiaries may apply for reinstatement in a manner prescribed for new applicants for membership, after making payment in full of all accounts due as of the date of termination.

Section 5. Deposits and Expenditures. Deposits and expenditures of funds shall be in accordance with the policies established by the board of directors. (Amend 1/05)
Section 6. Notice of Dues, Fees, Fines, Assessments and Other Financial Obligations of members. All dues, fees, fines, assessments, or other financial obligations to the association or association multiple listing service shall be noticed to the delinquent association member in writing setting forth the amount owed and due date.

Section 7. The dues of REALTOR ${ }^{\circledR}$ members who are REALTOR ${ }^{\circledR}$ Emeriti (as recognized by the National Association), past presidents and past treasurers of the National Association or recipients of the Distinguished Service Award shall be as determined by the board of directors. (Amended 11/2013)

## Article XI - Officers and Directors

Section 1. Officers. The elected officers of the association shall be: a president, a president elect and a secretary/treasurer. The term of office of the elected officers shall begin on October 1. They shall be elected for terms of one year.
(a) Term Limits. No officer shall serve more than two (2) consecutive one-year terms in any position.
(b) In order to serve as an officer, a member shall be required to have served as a director for a period of two (2) years.
(c) The Secretary/Treasurer will automatically succeed to the position of President-Elect unless they decline to do so. If the Secretary/Treasurer declines, then the nominating committee shall select at least one candidate for the position of president elect who can be the same persons as currently serve in those positions so long as they have only served for one (1) one-year term.
(d) The president elect will automatically succeed to the position of president unless the president elect declines to do so. If the president elect declines, then the nominating committee shall select at least one candidate for the position of president and at least one for president elect who can be the same persons as currently serve in those positions so long as they have only served for one (1) oneyear term.
(e) The President will automatically succeed to the position of Immediate Past president .
(f) Automatic succession to an officer's position will not preclude the Nominating Committee from recommending additional candidates.

Section 3. Duties of Officers. The duties of the officers shall be such as their titles, by general usage, would indicate and such as may be assigned to them by the board of directors. It shall be the particular duty of the Association Executive to keep the records of the association and to carry on all necessary correspondence with NATIONAL ASSOCIATION OF REALTORS ${ }^{\circledR}$ and the Illinois REALTORS ${ }^{\circledR}$. (Amended 1/05)
Section 4. Board of Directors. The governing body of the association shall be a board of directors consisting of the elected officers, the immediate past president of the association and eight (8) REALTOR ${ }^{\circledR}$ members of the Association. Directors shall be elected to serve for terms of three (3) years, except that at organization, one-third of the elected directors shall be elected for terms of one (1), two (2) and three (3) years, respectively, or for lesser terms as may be necessary to complete the first fiscal year. Thereafter, as many directors shall be elected each year as are required to fill vacancies. (Amended 1/05)
(a) Term Limits. No director shall serve for more than two (2) consecutive three (3) year terms. (Adopted 1/05)

## Section 4. Election of Officers and Directors.

(a) At least two (2) months before the annual election, a nominating committee of seven (7) REALTOR ${ }^{\circledR}$ members shall be appointed by the president with the approval of the board of directors. The nominating committee shall select at least one candidate for Secretary/Treasurer and at least one candidate for each place to be filled on the board of directors. The report of the nominating committee shall be mailed, or where permitted by state law, electronically transmitted to each member eligible to vote at least three (3) weeks preceding the July election. Additional candidates for offices to be filled

may be placed in nomination by petition signed by at least ten percent (10\%) of the REALTOR ${ }^{\circledR}$ members eligible to vote. The petition shall be filed with the Association Executive at least two (2) weeks before the election. The Association Executive shall send notice of such additional nominations to all members eligible to vote before the election. (Amended 1/05)
(b) The election of officers and directors shall take place at the July general membership meeting or where provided for by state law, electronically. Where permitted by state law, and in accordance with applicable state requirements, election of officers may be conducted by electronic means, in accordance with procedures established by the board of directors. (Adopted 1/05)

In case of a tie vote, the issue shall be determined by lot.
Section 5. Board of Directors Qualifications. The following criteria must be met in order to qualify as an applicant to the Board of Directors:
a. The applicant must complete and submit the application within the required timeframe. Late submissions will not be accepted.
b. The applicant must possess personal leadership skills and the ability to motivate others.
c. The applicant must be open to new ideas and concepts, even though they may increase risks of the association.
d. The applicant must possess the leadership skills necessary to accomplish the goals and objectives of the Association.
e. The applicant must be willing to familiarize themselves with the Association's programs, policies, budgets, objectives, and organizational structure.
f. The applicant must understand the duties and responsibilities as a fiduciary to the Association.
g. The applicant must be aware and accommodating to the diverse ethnic, racial, geographic, and business practices of the Association.
h. The applicant must have prior committee experience on at least one of the various Egyptian Board of Realtors ${ }^{\circledR}$ committees. (Amended 09/2020)
i. The applicant must be able to effectively balance any workload with their own real estate business and the workload associated with becoming a member of the Board of Directors.
j. The applicant must be aware of the methods in which their status as a member of the Board of Directors may terminate.

Section 7. Vacancies. All positions or appointments shall be filled by the President, who shall nominate such individual as he or she shall determine, and such nomination shall be approved by a majority of directors present at the meeting in which the nomination is made.

Section 8. Removal of Officers and Directors. In the event that an officer or director is deemed incapable of fulfilling the duties for which elected may be removed from the Board of Directors with cause under the following procedure:

1. A special meeting may be called by a simple majority vote of the Officers and Directors.
2. A certified letter must be sent to the Officer or Director under examination giving him/her notice of the time and place for the special meeting. The letter must be received at least 15 days or more prior to the date of the special meeting and must state the cause against the Officer or Director under examination.
3. The Board of Directors and/or the Officer or Director under examination may have legal counsel

present. The Officer or Director under examination will be given a chance to speak and refute any charges against him/her.
4. The Board may remove any Officer or Director without cause by a three-fourth (3/4) vote of all Directors then in office, at any regular or special meetings of the Board, provided that the Director subject to removal must be given at least 15 days' notice of the time and place where the Board is to take action on the removal. -(Amended 09/2020)
5. The details of such special meeting will remain confidential. (EBOR 11/17)

Section 7. Association Executive. There shall be an Association Executive, appointed by the board of directors, who shall be the chief administrative officer of the Association. The Association Executive shall have sole authority to hire, supervise, evaluate and terminate other staff, if any, and shall perform such other duties as prescribed by the board of directors. The Association Executive serves as the Chief Executive and Operating Officer of the Association and is responsible to the board of directors for the effective conduct of the affairs of the Association. (Adopted 1/05)

Article XII - Meetings
Section1. Annual Meetings. The annual meeting of the association shall be held during September of each year, the date, place and hour to be designated by the board of directors. (Adopted 1/05)

Section 2. Meetings of Directors. The board of directors shall designate a regular time and place of meetings to be held no less than every sixty (60) days. Special meetings of the directors shall be held at the call of the president or the written request of at least five (5) directors. Absence from two (2) regular meetings without an excuse deemed valid by the president and the Association Executive shall be construed as resignation. A quorum for the transaction of business shall be a majority of the board of directors, except as may otherwise be required by state law. (Amended 05/2013)

Members shall be allowed to attend meetings held by the Board of Directors, where space permits, and subject to the rules governing the conduct of the meeting as set forth by the Board of Directors, and the power of the President to regulate the orderly conduct of the meeting. The President or any other Officer so designated, shall exercise their discretion in determining whether, and to what extent, a member may address the Board of Directors at said meetings.

Section 3. Other Meetings. Meetings of the members may be held at other times as the president or the board of directors may determine, or upon the written request of at least $10 \%$ of the members eligible to vote.

Section 4. Notice of Meetings. Notice shall be given to every member entitled to participate in the meeting at least 72 hours preceding all meetings. If a special meeting is called, it shall be accompanied by a statement of the purpose of the meeting.

Section 5. Quorum for Membership Meetings A quorum for the transaction of business at general and/or special meetings of the membership shall consist of $10 \%$ of the members eligible to vote, except as may otherwise be required by state law. (Amended 05/2013)
Section 6. Electronic Transaction of Business. To the fullest extent permitted by law, the board of directors or membership may conduct business by electronic means. (Adopted 1/05)

Section 7. Action without Meeting. Unless specifically prohibited by the articles of incorporation, any action required or permitted to be taken at a meeting of the board of directors may be taken without a

meeting if consent in writing, setting forth the action so taken, shall be signed by all of the directors. The consent shall be evidenced by one or more written approvals, each of which sets forth the action taken and bears the signature of one or more directors. All the approvals evidencing the consent shall be delivered to the Association Executive to be filed in the corporate records. The action taken shall be effective when all the directors have approved the consent unless the consent specifies a different effective date. (Adopted 1/05)

Section 8. Certain events beyond the control of the Board of Directors, may inhibit the Board from fulfilling its duties and obligations as required by the Bylaws.

In the event of natural or political events that create risks beyond the reasonable control of the Board, which have a materially adverse effect on the ability to perform its obligations under these Bylaws, the procedure for fulfilling its obligations shall be in accordance with the Transition Planning Document, which shall be reviewed and adjusted from time to time by the Board of Directors.

Details of the Transition Planning Document are located in the Policy \& Procedures Manual. (Amended 09/2020)
Section 9. Attendance of a member at a Board of Directors Meeting. Members shall be allowed to attend meetings held by the Board of Directors, where space permits, and subject to the rules governing the conduct of the meeting as set forth in the Policy \& Procedures Manual. (Amended 09/2020)

## Article XIII - Committees

Section 1. Standing Committees. The president shall appoint from among the REALTOR ${ }^{\circledR}$ members, subject to confirmation by the board of directors, the following standing committees:

Section 2. Special Committees. The president shall appoint, subject to confirmation by the board of directors, special committees as deemed necessary.
When making appointments, the President and the Board of Directors should consider the following factors:
a. Number of years as a Realtor ${ }^{\circledR}$
b. Number of years in the real estate business
c. Minority Status
d. Primary and secondary fields of real estate endeavor/expertise
e. Participation in post-licensing real estate education
f. Training in the Code of Ethics
g. Familiarity with state laws and regulations

h. Receptiveness to instruction and training
i. Technical Experience
j. Digital/Social Media Experience

Section 3. Organization. All committees shall be of such size and shall have duties, functions, and powers as assigned by the president or the board of directors except as otherwise provided in these Bylaws.

Section 4. President. The president shall be an ex-officio member of all standing committees and shall be notified of their meetings.

Section 5. Action without Meeting. Any committee may act by unanimous consent in writing without a meeting. The consent shall be evidenced by one or more written approvals, each of which sets forth the action taken and bears the signature of one or more of the members of the committee. (Adopted $1 / 05$ ) Policy changes must be submitted to the board of directors for approval.
Section 6. Attendance by Telephone. Members of a committee may participate in any meeting through the use of a conference telephone or similar communications equipment by means of which all persons participating in the meeting can hear each other. Such participation shall be at the discretion of the president and shall constitute presence at the meeting. (Adopted 1/05)
Article XIV - Fiscal and Elective Year

Section 1. The fiscal year of the association shall be October 1 to September 30.
Section 2. The elective year of the association shall be October 1 to September 30.
Article XV - Rules of Order

Section 1. Robert's Rules of Order, latest edition, shall be recognized as the authority governing the meetings of the association, its board of directors, and committees, in all instances wherein its provisions do not conflict with these Bylaws.

## Article XVI - Amendments

Section 1. These Bylaws may be amended by a majority vote of the members present and qualified to vote at any meeting at which a quorum is present, provided the substance of such proposed amendment or amendments shall be plainly stated in the call for the meeting.
(a) When Bylaws amendments are mandated by NAR policy, these Bylaws may be automatically amended to reflect the mandate as of the effective date of the mandatory policy authorized by the NATIONAL ASSOCIATION OF REALTORS ${ }^{\circledR}$. The association shall provide notice of that change in a regular or special membership communication.
Section 2. Notice of all meetings at which amendments are to be considered shall be mailed to every member eligible to vote or notification sent by electronic means at least one (1) week prior to the meeting.

Section 3. Amendments to these Bylaws affecting the admission or qualification of REALTOR ${ }^{\circledR}$ and Institute Affiliate members, the use of the terms REALTOR ${ }^{\circledR}$ and REALTORS ${ }^{\circledR}$, or any alteration in the
territorial jurisdiction of the association shall become effective upon their approval as authorized by the board of directors of the NATIONAL ASSOCIATION OF REALTORS®.

Article XVII - Dissolution
Section 1. Upon the dissolution of this association, the board of directors, after providing for the payment of all obligations, shall distribute any remaining assets to the Illinois Association of REALTORS ${ }^{\circledR}$ or, within its discretion, to any other non-profit tax-exempt organization.

Article XVIII - Multiple Listing

## Subsidiary Multiple Listing Corporation

The association of Realtors ${ }^{\circledR}$ shall maintain for the use of its members a multiple listing service which shall be a lawful corporation of the state of Illinois, all the stock of which shall be owned by the Capital Association of Realtors ${ }^{\circledR}$, Egyptian Board of Realtors ${ }^{\circledR}$, Peoria Association of Realtors ${ }^{\circledR}$ and the Quad City Association of Realtors ${ }^{\circledR}$ hereafter called the Regional MLS Alliance, LLC. (Amended 09/2020)

## ARTICLE XIX - Indemnification

1. The corporation, Egyptian Board of REALTORS, ${ }^{\circledR}$ Inc., does hereby indemnify any person who was or is a party, or is threatened to be made a party to any threatened, pending or completed action, suit or proceeding, whether civil, criminal, administrative or investigative (other than an action by or in the right of the corporation) by reason of the fact that he/she is or was a director, officer, employee or agent of the corporation, or who is or was serving at the request of the corporation as a director, officer, employee or agent of another corporation, partnership, joint venture, trust or other enterprise, against expenses (including attorneys' fees), judgments, fines and amounts paid in settlement actually and reasonably incurred by him/her in connection with such action, suit or proceeding, if he/she acted in good faith and in a manner he/she reasonably believed to be in, or not opposed to the best interest of the corporation, and, with respect to any criminal action or proceeding, had no reasonable cause to believe his/her conduct was unlawful. The terminations of any action or suit or proceeding by judgment, order, settlement, conviction, or upon a plea of nolo contendre, or its equivalent, shall not, of itself, create a presumption that the person did not act in good faith and in a manner which he/she reasonably believe to be in, or not opposed to the best interest of the corporation, and, with respect to any criminal action or proceeding, had reasonable cause to believe his/her conduct was unlawful.
2. The corporation does hereby indemnify any person who was or is a party, or is threatened to be made a party to any threatened, pending or completed action, suit or proceeding, whether civil, criminal, administrative or investigative (other than an action by or in the right of the corporation) by reason of the fact that he/she is or was a director, officer, employee or agent of the corporation, or who is or was serving at the request of the corporation as a director, officer, employee or agent of another corporation, partnership, joint venture, trust or other enterprise, against expenses (including attorneys' fees), actually and reasonably incurred by him/her in connection with the defense or settlement of such action or suit, if he/she acted in good faith and in a manner which he/she reasonably believe to be in, or not opposed to the best interest of the corporation, except that no indemnification shall be made in respect of any claim, issue or matter as to which such person shall have been adjudged to be liable for negligence or misconduct in the performance of his/her duty to the corporation, unless and only to the extent that the court in which such action or suit was brought

shall determine upon application that, despite the adjudication of liability, but in view of all the circumstances of the case, such person is fairly and reasonably entitled to indemnity for such expenses as the court shall deem proper.
3. To the extent that a director, officer, employee or agent of the corporation has been successful, on the merits or otherwise, in the defense of any action, suit or proceeding referred to in paragraphs 1. and 2. above, or in defense of any claim, issue or matter therein, he/she shall be indemnified against expenses (including attorneys' fees) actually and reasonably incurred by him/her in connection herewith.
4. Any indemnification under paragraphs 1 and 2 above (unless ordered by court) shall be made by the corporation only as authorized in each specific case, upon a determination that indemnification of the director, officer, employee or agent is proper in the circumstances because he/she has met the applicable standard of conducts set forth in paragraphs 1 and 2 above. Such determination shall be made (a) by the board of directors who are disinterested parties to such action, suit or proceeding, or (b) if such a quorum is not obtainable, or even if obtainable, a quorum of disinterested directors so directs, by independent legal counsel in a written opinion, or (c) by the members. (Amended 09/2020)
5. Expenses incurred in defending a civil or criminal action, suit or proceeding may be paid by the corporation in advance of the final disposition of such action, suit or proceeding, as authorized by the board of directors in each specific case, upon receipt of an undertaking by or on behalf of the director, officer, employee or agent to repay such amount, and upon approval by a majority of disinterested directors, unless it shall ultimately be determined that he/she is entitled to be indemnified by the corporation as authorized in this action. (Amended 09/2020)
6. The indemnification provided herein shall not be deemed exclusive of any other rights to which those seeking indemnification may be entitled under any bylaw, agreement, vote of members or disinterested directors or otherwise, both as to action in his/her capacity, and as to action in another capacity while holding such office, and shall continue as to a person who has ceased to be a director, officer, employee or agent, and shall insure to the benefit of the heirs, executors and administrators of such person.
7. The corporation may purchase and maintain insurance on behalf of any person who is or was a director, officer, employee or agent of the corporation, or who is or was serving at the request of the corporation as a director, officer, employee or agent of another corporation, partnership, joint venture, trust or other enterprise, against any liability asserted against him/her, and incurred by him/her in any such capacity, or arising out of his/her status as such, whether or not the corporation would have the power to indemnify him/her against such liability under the provisions of this section.

## Definitions

"Association" when used alone means any Association/Board of REALTORS ${ }^{\circledR}$ chartered by the National Association of Realtors ${ }^{\circledR}$
"AE or Association Executive" refers to the chief operating officer of an Association
"Association Staff" refers to the employees of the Association Executive.
"Board" refers to the Board of Directors of an Association

"CMLS or Council of Multiple Listing Services" is an advisory council established to create Best Practices an d make recommendations to member MLS entities. CMLS also makes recommendations to NAR for Multiple Listing Policy.
"Committee" means any group of members appointed for a specific task by the current President of the Board of Directors and approved by same Board of Directors.
"Council" means the MLS Council of the RMLS Alliance, LLC
"Dues" refers to the annual amount paid to the Local, State and National Association of Realtors ${ }^{\circledR}$ for membership in the organization.
"Fees" refers to the quarterly amount paid to the Local Association for services provided.
"Membership or Members" refers to all Active individuals of an Association
"MLS or Multiple Listing Service" refers to the database supplied by the Association or by a separate MLS entity such as the RMLS Alliance, LLC.
"Other Participant" means a Participant, otherthan the listing Participant, who is working with a prospective buyer(s) or tenant(s) of listed property as a buyer or tenant agent or in any other agency or non-agency capacities as defined by law.
"Participant" means an eligible Designated REALTOR ${ }^{\circledR}$ Member of an MLS Entity
"RESO or Real Estate Standards Organization" is a group established to bring standard terms used within an MLS database. MLS entities under NAR are now mandated to comply with RESO standards.
"RMLS" means the Regional MLS Alliance, LLC which is comprised of four (4) founding Associations: Egyptian, Capital Area, Peoria Area, Quad Cities.
"RMLS Staff" refers to the administrative staff of the RMLS whether contractual or employed.
"SSO or Single Sign on Dashboard" is a tool created by Clareity and available to Members to enable them to access various integrated internet sites without using multiple passwords.
"Subscriber" (or "user of the MLS") means an individual who is either (i) a non-principal broker, sales associate, or (ii) a licensed or certified appraiser affiliated with a Participant. Subscriber includes each licensed person, whether licensed as a broker or as a salesperson, including a licensed or certified appraiser, who is employed by or affiliated with a Participant as an employee, or as an independent contractor.
"User" refers to a Participant or Subscriber of an MLS. Also known as a Subscriber.
"Vendor" refers to the provider of a service or product provided to a Member.
