#### **EBOR Web Portal**

- Access through the RMLS Dashboard: <a href="https://rmlsa.clareity.net/">https://rmlsa.clareity.net/</a> Then click EBOR Portal icon (No login information needed)
- View the board calendar, register for upcoming events, meetings, and pay orders (invoices)

### EBOR Website (<u>www.egyptianboard.realtor</u>)

- Obtain local board of directors, member & office directories
- "Members Only" section on the board website. Print/save important board-approved contracts & forms, REALTOR® membership forms and registrations. Print/view agendas, minutes and financial statements of BOD meetings.

#### NAR (www.nar.realtor)

Click "Register" on the upper right-hand section of the webpage. You will need your NRDS#. You will be able to "Login" anytime with the username and password you created when you registered. Now you can:

- Update your NRDS information by clicking on "My Account" and pay your dues (click on "Pay Dues")
- Take online Code of Ethics training
- Find logos & REALTOR trademarks for your documents
- Find out about member benefits, including discounted services (Dell, FedEx, etc.)
- Find Core Health Insurance & NAR Credit Union information
- NAR Certifications, Designations and Graduate School of Real Estate
- Register for NAR conferences and expos
- Information on Law, Ethics & Policy
- Involvement Advocacy & REALTOR Political Action Committee
